In February 2021, NCLWF received 108 applications, requesting \$76,595,676. The breakdown by program area is shown in the table below.

Agenda Item 6) Discussion on Funding Caps

Beginning in the 2011 grant cycle, the board chose to cap the award amounts at the funding meeting in order to make funding available to more projects around the state. That has continued to be the practice in years since. The most recent caps were set at \$1,200,000 for acquisition, \$400,000 for restoration, and \$100,000 for innovative stormwater at the 2020 funding meeting. While no caps have been officially set for 2021, and staff directs applicants to request the full funding that they need for a project, many applicants assumed that a cap would be established and made their request accordingly. Depending on where the final budget is when the board meets in September, the committees may choose not to set a cap this year. As members of both committees are present, this will be the only opportunity to discuss this issue together before the funding meeting.

Agenda Item 7) Allocation (%) of Funding for 2021 Applications

Background information

For the past seven years, the NCLWF Board has allocated 75% of funds to Acquisition applications and the remaining 25% to Stream Restoration and Innovative Stormwater. Prior to 2018, the Board further allocated 20% to Restoration and up to 5% to Innovative Stormwater. Planning was funded from the committee that most aligned with the purpose of the plan. Beginning in 2018, the Board employed a simplification of the allocation process in which the Restoration, Innovative Stormwater and Planning Committee would determine the funding between their three program areas at the board meeting based on the merit of the applications.

As of the writing of this agenda item, there is still some uncertainty about the budget, but the breakdown of the 2021 applications between the programs is as follows:

Staff recommendation based on previous allocations

The committee recommends for the 2021 grant cycle that all new revenue be allocated as follows: ____% of funds to the Acquisition Committee, ____% of funds to the Restoration, Innovative Stormwater, and Planning Committee. The Acquisition Committee will be charged with allocating funding for the Donated Minigrant Program. The Restoration, Innovative Stormwater and Planning Committee will be charged with allocating funding for each of their three program areas based on the merit of the applications during project review. All unspent funds from previous grants will revert to their respective programs, excluding wastewater, which will be treated as new revenue and assigned to each program according to the aforementioned allocation percentages.
