Agenda Item: Consent addition: Request to extend the date to enter into a construction contract for existing Restoration Program Grant.

<u>Background:</u> NCLWF wastewater, stormwater, and restoration construction projects approved after January 1, 2006 are subject to NCGS §113A-254 requiring grant recipients to enter into a construction contract for the project within one year after grant award. The statute states that the award is withdrawn unless the NCLWF Board of Trustees finds that the applicant has good cause for failing to meet this requirement. The statute further states that, if the Trustees find good cause for the failure, they then must set a date by which the grant recipient must take action or forfeit the grant.

The Town of Caswell beach has requested an extension of the date to enter into a construction contract and has provided a summary of the reasons for their delay in entering into a construction contract (see attached). This request was received on November 23, 2020, shortly after the agenda was set for the December 1, 2020 NCLWF Board meeting.

<u>Staff recommendation:</u> Staff supports this extension request as the grantee has made a good faith effort to meet project deadlines but was delayed due to delays in NCDOT funding. Further, COVID-19 has complicated work for project partners. Staff proses to extent the construction contract deadline to September 30, 2021, rather than the requested date of March 31, 2021, to be in line with the construction contract deadlines for other NCLWF construction projects.
